

June 30 2024 Offer Terms & Conditions 2024 Offer 1 – Pay Now Collect Later

- 1. For product purchased (ordered and paid for) before 26th June 2024.
- 2. Product in this offer must be collected from Whitfert storage from 1st July 2024 and not after 12 months from the date of invoice.
- 3. Product nominated in Offer 1 must be collected from Whitfert storage before the same product can be collected under any other Whitfert 2024/25 Fertilizer Contract or offer.
- 4. Product which has not been collected by the dates stated in paragraph 2 above will be returned to Whitfert's stock and monies paid for that product in June 2024 will not be refunded.
- 5. The offer is available on most of Whitfert's product range, although some products may be restricted on first come first served basis due to limited quantities. Whitfert will advise customers at the time of ordering whether product restrictions apply to the product requested.
- 6. The sales contract is on a fixed supply basis irrespective of whether international prices move up or down during the 2024/25 season. In all other respects the sales contract is subject to Whitfert's General Terms and Conditions of Sale (refer: www.whitfert.com.au/images/terms-conditions/Terms Conditions Sale Whitfert.pdf).
- 7. If the customer chooses a 10% deposit option as payment, then the 10% deposit must be paid prior to 26th June 2024. The sum payable will be <u>10% of the total invoice value including GST</u>. The outstanding balance will be due and payable no later than 25th January 2025, or on collection if prior to this date.
- 8. Orders will be confirmed if payment is made by 26th June 2024.
- 9. Product is invoiced before 30th June 2024 and as such is owned by the customer and held in storage by Whitfert.
- 10. No product changes or refunds are available after 30th June 2024 and product must be collected before the dates outlined in paragraph 2 above.
- 11. No other discount offers can be used in conjunction with this offer.
- 12. This offer is not open to resellers or buying groups.
- 13. The purchase price includes product insurance up until the product has been collected from Whitfert storage.
- 14. All credit payment types require Whitfert Fertilisers credit approval.

- Pre-pay a lump sum amount into your Whitfert Fertilisers account before the 26th of June 2024, up to a maximum amount of AUD\$1.5 million plus GST, per Whitfert Fertilisers account. The pre-payment will be invoiced as "EOFY 2024 Pre-paid Fertilizer" prior to 30th June 2024.
- 2. Pre-paid funds must be paid in full. No deposit options are available under Offer 2 Pre-Pay Now Nominate Later.
- 3. No cash refunds will be available. Funds will be held in your Whitfert Fertilisers account and must be used for fertiliser purchases only. Any funds remaining 12 months after the invoice date of prepayment amount will be forfeited.
- 4. Pre-paid funds can only be used for collections between 1st August 2024 and 12 months after the date of invoice.
- 5. Monies paid to Whitfert as a part of this 2024 Pre-Pay Now Nominate Later offer will qualify for a reward as set out below. The reward amount is not interest.
- 6. Customers will be entitled to receive a reward amount calculated daily at an annual percentage rate of 5.0% on the funds that are held in your Whitfert Fertiliser account at that time during the period 1st July 2024, until 25th February 2025.
